It has been fourteen years now since the Outstanding Overseas Taiwanese SMEs Award were established in 1999. Over the years, judges from industry, government, and academic circles have maintained an objective, fair, and unimpaired attitude to evaluate all nominees. As every winner is a model of overseas Taiwanese businesses, it is hoped that by commending the experiences of success of these overseas Taiwanese businesses, we can encourage other overseas Taiwanese businesses to exert their influence, so as to create a boom of overseas Taiwanese businesses.

First of all, I would like to pay my sincerest congratulations to the winners of the 14th Overseas Outstanding Taiwanese SMEs Award on behalf of the World Taiwanese Chambers of Commerce (WTCC).

Overseas Taiwanese businesses are a specific phenomenon in Taiwan's economic development. Compared with the overseas businesses from Europe, the USA, Japan, or Korea, although the scale on average of overseas Taiwanese businesses is comparatively smaller, the overall quantity is greater. Also, most of them are startups working hard on their own in different parts of the world to start a business from scratch, from small to big with limited resources, so as to build an unlimited future against adversities. This kind of aggressive native entrepreneur spirit fully demonstrates the multidimensional and oceanic "Taiwanese spirit" emerging from contemporary Taiwanese culture. The "Taiwanese business effect" arising from the worldwide investments of Taiwanese businesses turns Taiwanese businesses into a specific power in the global economy. In order to unite such power and build a world Taiwanese trade network to demonstrate the synergy of overseas Taiwanese businesses, the World Taiwanese Chambers of Commerce was formed.

It has been 18 years now since WTCC was founded on 14 September 1994. Today, WTCC has about 40,000 members from 172 local chambers of commerce in 67 countries and regions under six continental branches. Whether it is uniting the power of worldwide overseas Taiwanese businesses or providing business information and opportunities and promoting trade cooperation so as to gain protection from the host countries for the rights and benefits for overseas Taiwanese businesses, WTCC and branches have exerted great effect on such events and have successfully promoted the image and foreign relations of Taiwan with admiring achievements that make us proud.

In the past year, however, after participating in the events of six continental WTCC branches and local chambers of commerce, I realized that the first generation of overseas Taiwanese businesses have grown old, and there is a succession crisis; and the legacy problem of the WTCC has also emerged. In addition to the loyalty to and identification with Taiwan of the second-generation overseas Taiwanese businesses or overseas Taiwanese compatriots, this will also affect Taiwan's economic development. Hence, the government should not overlook this issue.

The aim of the Outstanding Overseas Taiwanese SMEs Award is to commend the outstanding operational achievements of overseas Taiwanese businesses and their contribution to society, the nation, and overseas Taiwanese groups. We hope that under the aurora of the award, they can better fulfill their corporate social responsibility and continuously support the next-generation young Taiwanese businesspersons, so as to continue the lineage of overseas Taiwanese businesses forever and ever, and thereby to "develop Taiwan and deploy in the world" and link up with domestic businesses to create business opportunities to support the economic development of Taiwan.

Lastly, I am thankful to the Overseas Chinese Affairs Council and the Small and Medium Enterprise Administration for their supervision, and the efforts and devotions of the National Association of Small and Medium Enterprises, Director Chen of the World Taiwanese Chambers of Commerce, and the crew of the award. Without your participation, the Outstanding Overseas Taiwanese SMEs Award wound not have been a success.

海外台商磐石獎評審作業說明

Judging Procedure of the Outstanding Overseas Taiwanese SMEs Award

爲表彰海外經營企業有成,各方面表現卓越,且對台灣或僑居地等國際社會有貢獻之台商企業,由僑務委員會指導,並由經濟部中小企業處、中華民國全國中小企業總會以及世界台灣商會聯合總會共同舉辦第14屆「海外台商磐石獎」選拔表揚活動。

本年度自3月15日至7月15日受理申請,7月16日至8月10日由本會組成初審工作小組,就參選企業進行資格審查。

8月13日至8月23日由複審委員進行書面審查,並於8月24日召開複審會議,針對參選企業之「經營特色與其獨特價值」、「公益投入與表現」、「環保措施」、「整體管理制度」及「財務績效」等予以評核,經綜合討論後決議10家企業進入決審階段。

決審會議於9月13日召開,由僑委會副委員長任弘代理擔任決審主任委員,邀集來自產、官、學領域的委員進行審查, 針對「整體管理制度健全堪爲楷模」、「可爲海外台商企業經營示範效果」及「對我國或當地社會有具體貢獻」等構面予 以評核,經綜合討論後計8家企業當選第14屆海外台商磐石獎。

全球的台商企業對於延伸我國產業實力,一直扮演著舉足輕重的角色,期藉由海外台商磐石獎的選拔與表揚,將傑出的海外台商予以整合,擴展海外經營經驗與國內企業相互學習觀摩,本(14)屆得獎企業來自美國、南非、泰國、越南、新加坡、澳洲,產業範圍涵蓋了資訊服務、電腦與網通器材代理、金融業、電壓器與變頻器開發、刨花板與橡膠木板材製造、揚聲器導磁元件、塑膠射出成型加工、薄荷腦及相關產品製造,這些企業除了經營績效表現卓越外,對於家鄉及僑居地之回饋更是不遺餘力,努力爲台灣帶來崇高的國際形象,足堪稱爲海外台商企業之典範。

In order to commend overseas Taiwanese SMEs with great operational achievements, outstanding performance, and contributions to Taiwan and international society, such as the host country of their businesses, the Small and Medium Enterprise Administration (SMEA) of the Ministry of Economic Affairs (MOE), National Association of Small and Medium Enterprises (NASME), and the World Taiwanese Chambers of Commerce (WTCC) co-organized the 14th Outstanding Overseas Taiwanese SMEs Award under the supervision of the Overseas Chinese Affairs Council (OCAC).

The acceptance of applications was from March 15th to July 15th. From July 16th to August 10th, the preliminary review panel was formed to review the eligibility of applicants.

From August 13th to 23rd the second review panel conducted the document review. On August 24th the second review panel held a discussion meeting to rate the 'operational characteristics and uniqueness', 'charity involvement and performance', 'environmental protection measures', 'overall management system', and 'financial performance' of applicants. After further discussions, ten applicants were selected for the final review.

On September 13th the final review meeting was held, with OCAC Deputy Minister Hong JEN acting as the chairperson, and experts from the industry, the government, and the academic circle as members. At the meeting, members reviewed the finalists in terms of their 'well-structured overall management system serving as a model', 'outstanding operational performance as demonstration for overseas Taiwanese SMEs', and 'contributions to Taiwan and the host country'. After further discussions, eight applicants were selected as the winners of the 14th Outstanding Overseas Taiwanese SMEs Award.

Worldwide Taiwanese SMEs have been playing a decisive role in extending the industrial power of Taiwan. By selecting and commending outstanding overseas Taiwanese SMEs with the Outstanding Overseas Taiwanese SMEs Award, we hope to integrate overseas Taiwanese SMEs to extend the overseas operation experience and simulate the mutual learning of domestic SMEs. Geographically, winners of this year (2012) were from the USA, South Africa, Thailand, Vietnam, Singapore, and Australia. Industrially, they cover the IT service, computer and netcom equipments distribution, finance, transformer and inverter development, particle board and rubber lumber manufacture, speaker magnetic material, plastic mold injection processing, and the manufacture of menthol and related products. Aside from outstanding operational performance, these winners have spared no effort in requiring their hometown and the host country of their enterprises to improve Taiwan's international image. They thus deserve to be the model of overseas Taiwanese businesses.
